ACTIVITIES TO BE UNDERTAKEN:

Neither party shall be liable for any indirect, incidental, special, or consequential damages arising out of or in connection with this MOU or the activities undertaken pursuant to this MOU.

This MOU shall be governed by and construed in accordance with the laws of India.

This MOU may be amended or modified only by written agreement between the parties.
