### 3. Penalties for Sexual Harassment

Any person found guilty of sexual harassment shall be liable for the following punishments as per [AICTE Regulations](#):

#### For Students:

- **Minor Offense:** Mandatory reformatory counseling, written apology, or formal warning. Parents undertaking for better behavior in future.
- **Moderate Offense:** Suspension from classes, withholding of scholarships, or debarment from participating in college events/campus placements. Parents undertaking for better behavior in future.
- **Major Offense:** Suspension for a full semester or debarment from examinations for up to 3 years and Parents will be informed and Police Case will be filed
- **Severe Offense: Rustication or Expulsion** from the college including issue of TC. Parents will be informed and Police Case will be filed

#### For Employees (Teaching & Non-Teaching):

- **Censure/Reprimand:** Formal record of misconduct in the service book and warning for better behavior.
- **Financial Penalty:** Withholding of increments or promotion.
- **Administrative Action:** Reversion to a lower post or grade.
- **Termination: Compulsory retirement or Dismissal** from service and Police Case will be filed.
