**Salient Features**

- Ragging within or outside any educational institution is Prohibited.
- Ragging means doing an act which causes or is likely to cause Insult or Annoyance of Fear or Appreciation or Threat or Intimidation or outrage of modesty or Injury to a student.

**Ragging is Prohibited**

1. Ragging is Prohibited as per Act 26 of A.P. Legislative Assembly, 1997.  
 2. Ragging entails heavy fines and / or imprisonment.
